QUALIFIED APPLICATION PROGRAM-LEVEL 3

Format: Three-Hour Online Webinar conducted and supervised by a Flame Seal expert.

Objective: This is a second training tier. It includes all the issues involved in complex projects: freezers, cold storage, extremely cold environments, and wet environments. Level 3 training is conducted via Webinar that is NOT automated, but rather is supervised by one of Flame Seal's expert trainers.
