JM Corbond III, JM Corbond MCS, JM Corbond III 2.8, JM Corbond oc SPF and JM Corbond ocx SPF products ("Product(s)") are subject to the following limited Product warranty when installed by a Johns Manville Approved Contractor in accordance with all of Johns Manville's current installation guides:

Johns Manville warrants that for a period of ten years from the date of proper installation the Product will be free from defects in material and the Side A and Side B components of Products are manufactured in all material respects to Johns Manville's Product specifications for such components. Note: Johns Manville's Products may vary in details of design and construction from descriptions in any literature or from any sample, display or other model inspected by Purchaser.

JOHNS MANVILLE DISCLAIMS ALL OTHER REPRESENTATIONS AND WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, IN FACT OR IN LAW, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTY OF MERCHANTABILITY AND THE IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE. Every claim under this limited warranty shall be deemed waived unless presented in writing and received by Johns Manville, at the address indicated below, within 10 days of installation if visibly damaged or defective, and, otherwise, within 30 days after the defect to which each claim relates is discovered, or should have been discovered, but in no event longer than one year after installation.

LIMITATION OF REMEDY: THE EXCLUSIVE REMEDY AND THE LIMIT OF JOHNS MANVILLE'S LIABILITY FOR BREACH OF THE LIMITED WARRANTY SET FORTH ABOVE, WHETHER BASED ON NEGLIGENCE, BREACH OF WARRANTY, STRICT LIABILITY, OR ANY OTHER THEORY AT LAW OR IN EQUITY, SHALL BE, AT JOHNS MANVILLE'S SOLE OPTION, REPAIR, REPLACEMENT WITH A LIKE QUANTITY OF NONDEFECTIVE PRODUCT OR REFUND OF THE PURCHASE PRICE OF THE DEFECTIVE PRODUCT.
